REQUIREMENTS FOR A LEGAL CEREMONY



WEDDINGS OFFICIATED AT LAS VENTANAS AL PARAÍSO ARE VALID AND RECOGNIZED IN ALL COUNTRIES INCLUDED IN THE HAGUE AGREEMENT, PROVIDED THAT THE CONDITIONS BELOW ARE MET.

PLEASE NOTE THAT THE MEXICAN JUSTICE OF THE PEACE REQUIRES THE FOLLOWING DOCUMENTS A MINIMUM OF EIGHT BUSINESS DAYS PRIOR TO THE CEREMONY IN ORDER TO COMPLETE THE NECESSARY PAPERWORK.

- CIVIL CEREMONY PERFORMED BY A MEXICAN JUSTICE OF THE PEACE
 - THE CEREMONY IS CONDUCTED IN SPANISH, WITH THE OFFICIATING MINISTER PROVIDING TRANSLATION SERVICES.
- COPIES OF BIRTH CERTIFICATES
- BLOOD TESTS
 - IN ACCORDANCE WITH MEXICAN LAW, BLOOD TESTS MUST TAKE PLACE IN MEXICO, TWO BUSINESS DAYS PRIOR TO THE WEDDING.
- COPIES OF PASSPORTS
- COPIES OF MEXICAN VISAS OR TOURIST CARDS RECEIVED UPON ARRIVAL IN MEXICO
- COPIES OF DIVORCE DECREES, IF APPLICABLE
- FOUR WITNESSES
 - FOR WEDDINGS OF TWO, LAS VENTANAS AL PARAÍSO IS PLEASED TO PROVIDE WITNESSES.
